LEGISLATION:

- 1. Ordinance No. 188-07 (Kelley/Ward 16): Authorizing the Director of Port Control to enter into a property adoption agreement with the Cleveland National Airshow foundation for the display of two statue-type F-4 fighter planes on property located near the entrance of Cleveland Burke Lakefront Airport, including maintenance of the property.
- 2. Ordinance No. 252-07 (Zone/Ward 17): Determining the method of making the public improvement of constructing improvements to the Parma Control, Nottingham and Central Warehouse facilities, and the Crown, West Park and Strongsville maintenance facilities; and authorizing the Director of Public Utilities to enter into one or more public improvement contracts for the making of the improvement.
- 3. Ordinance No. 256-07 (Pierce Scott/Ward 8): Authorizing the Director of Community Development to enter into an amendment to the Lease between the City and Cuyahoga County for real property located north and adjacent to the Main Avenue Bridge between West 6th Street and West 9th Street; and to enter into an amendment to the Sublease of the property from the City to Water Street Associates, Ltd., or its designee, to provide ingress and egress to the Water Street building and parking area, located at 1033 West 9th Street, available to the residents.
- 4. Ordinance No. 286-07 (Cimperman/Ward 13): Authorizing the director of Finance to enter into an agreement with the Greater Cleveland Regional Transit Authority and Cuyahoga County to share fiber optic resources; and to execute a deed of easement granting to Cuyahoga County certain easement rights in property located at 205 St. Clair and declaring the easement rights not needed for public use.
- 5. Ordinance No. 289-07: Authorizing the Director of Public Utilities to apply for and accept grants and gift s from public and private entities to conduct wind monitoring and other research on wind as a possible energy resource to the Department of Public Utilities; authorizing the purchase by one or more requirement contracts of materials, equipment, supplies and services to implement the project; determining the method of making the public improvement of installing wind monitoring equipment; authorizing the director to enter into one or more public improvement contracts for making the improvement; and authorizing the director to employ one or more professional consultants necessary to design the improvement, collect and analyze the data, create a feasibility study, and other services necessary to implement the project.

ADMINISTRATION APPROVALS

- 1. <u>Ordinance No 254-07</u>: Determining the method of making the public improvement of repairing and constructing roadways, bus pads, sidewalks, driveway aprons, curbs, curb ramps, brick streets, and appurtenances and authorizing the Director of Public Service to enter into one or more public improvement requirement contracts for the making of the improvement.
- 2. Ordinance No. 255-07 (Cimperman/Ward 13: Giving consent of the City of Cleveland to the Cuyahoga County Commissioners for the rehabilitation of the Columbus road Lift Bridge; authorizing the Director of Public Service to enter into any relative agreements; to apply for and accept an allocation of County Motor Vehicle License Tax Funds for the improvement; and causing payment of the City's share to the County for the cost of the improvement.
