

**Cleveland City Planning Commission
Draft Agenda – Regular Meeting 4/21/06**

Legislation

1. Ordinance No. 567-06: To amend the title and Section 3 of Ordinance No. 837-05, passed June 6, 2005, relating to making the public improvement of constructing general improvements to the Willard Park garage; to supplement the ordinance by adding new Section 3; and to renumber existing Sections 3 and 4 to new Sections 4 and 5.
2. Ordinance No. 568-06: To amend the title and Section 14 of Ordinance No. 1524-03, passed August 13, 2003, relating to the reconstruction of East 93rd Street between Union Avenue and Miles Road; to supplement the ordinance by adding new Sections 14 & 15; and to renumber existing Sections 14 and 15 to new Sections 16 & 17.
3. Ordinance No. 606-06: Authorizing the Mayor to accept a grant from the Ohio Public Works Commission for Denison Avenue Resurfacing from West 73rd St. to Lorain Avenue ; to authorize the Director of Public Service to hire one or more consultants for design, engineering and construction services; determining the method of making the public improvement of resurfacing Denison Avenue; authorizing the Director to enter into one or more public improvement contracts for the making of the improvement; and authorizing the Commissioner of Purchases and Supplies to acquire for right-of-way purposes real property necessary to make the public improvement.
4. Ordinance No. 608-06: Authorizing the Mayor to accept a grant from the Ohio Public Works Commission for Bellaire road Rehabilitation from West 117th Street and to authorize the Director of Public Service to hire one or more consultants for design; engineering and construction services; and authorizing the commissioner of Purchases and Supplies to acquire for right-of-way purposes such real property as is necessary to make the public improvement.
5. Ordinance No. 609-06: Authorizing the Mayor to accept a grant from the Ohio Public Works Commission for Quincy road Rehabilitation from East 40th St. to Woodhill Road; to authorize the Director of Public Service to hire one or more consultants for design, engineering and construction services; and authorizing the commissioner of Purchases and Supplies to acquire for right-of-way purposes such real property as is necessary to make the public improvement.
6. Ordinance No. 615-06: An emergency ordinance authorizing the sale of real property as part of the land Reutilization Program and located on East 49th St. to Lake Erie Barber College.
7. Ordinance No. 616-06: An emergency ordinance authorizing the sale of real property as part of the Land Reutilization Program and located on Clover Avenue to JDS Development LLC.

8. Ordinance No. 653-06: Authorizing the Director of City Planning to enter into one or more contracts with Cleveland Public Art for professional Services necessary to administer the City's public art program.
