- 1. <u>Ordinance No. 1277-06 (Lewis/Ward 7)</u>: Determining the method of making the public improvement of constructing the Keller II Water Tower at the City of Brunswick and authorizing the Director of Public Utilities to enter into one or more public improvement contracts for the making of the improvement.

- 5. <u>Ordinance No. 1284-06 (Cleveland/Johnson/Wards 5&4)</u>: Establishing the Burten Bell Carr Business Revitalization District.
- 6. <u>Ordinance No. 1274-06 (Conwell/Ward 9)</u>: Determining the method of making the public improvement of renovating the City Kennels, and authorizing the Director of Public Safety to enter into one or more public improvement contracts for the making of the improvement.
- 7. <u>Ordinance No. 1275-06 (Conwell/Ward 9)</u>: Authorizing the Director of Public Safety to lease certain property located at 9801 Walford Avenue from Walford Industrial Park, LLC, for a term of ten years, for the public purpose of operating an emergency medical services base station and for ancillary uses related to the base station.
